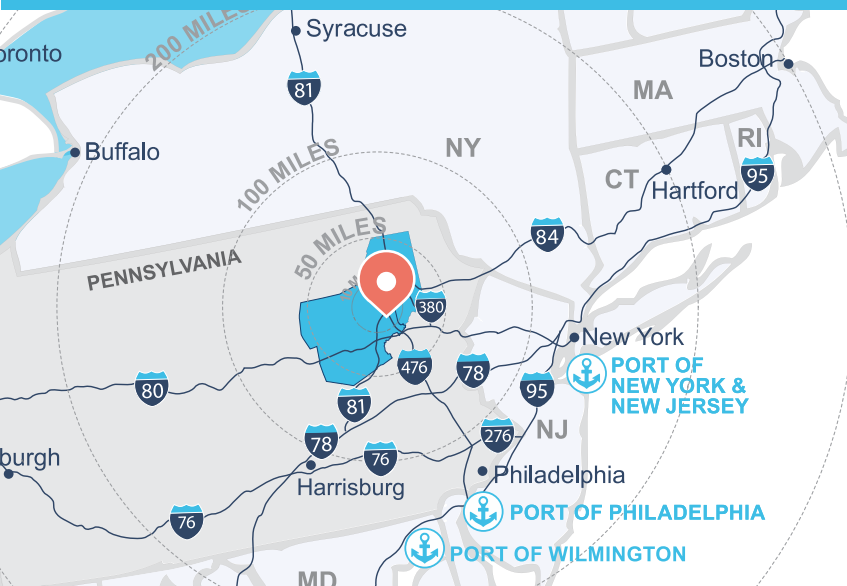

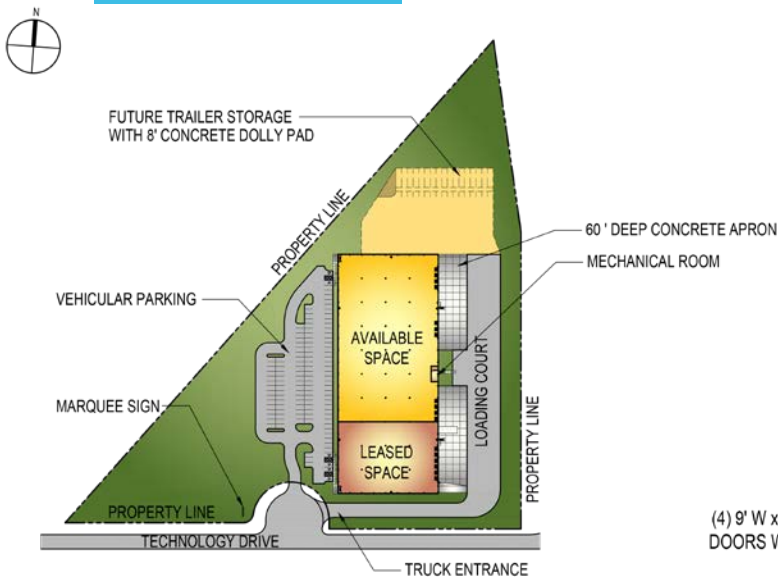

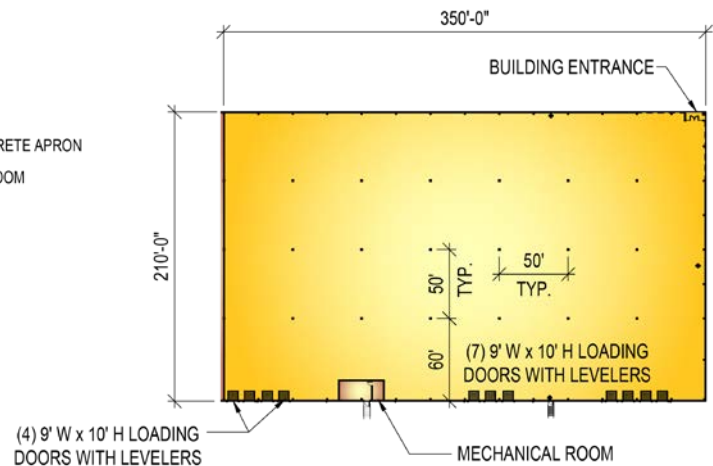

SIZE

- **Available Space:** 73,346 SF
- **Acreage:** 11.30 acres
- **Building Dimensions:** 210' (length) x 500' (depth)
- Tenant space availability ranges from 21,000 SF to 73,346 SF.

BUILDING CONSTRUCTION

- **Floor:** 6" thick concrete floor slab, reinforced with welded steel mats. Floor is treated with *SpecHard* silicate sealer/densifier and *E-Cure* curing compound.
- **Roof:** *Butler Manufacturing*, MR-24 metal roof system.
- **Exterior Walls:** Architectural masonry, aluminum/glazing entrance systems and metal wall panels with insulation.
- **Clear Ceiling Height:** 32'-2" approximate clear structural height along loading dock wall.
- **Bay Spacing:** 50'-0" x 50'-0" bay spacing with a 60'-0" deep staging bay.
- The building contains 3'-0" high x 6'-0" wide clerestory windows.

LOADING

- **Loading:** Single-sided loading.
- **Dock Equipment:** Eleven (11) 9'-0" x 10'-0" vertical lift dock doors with vision kits by *Haas Door* or equal with 40,000 lb capacity mechanical levelers with bumpers by *Rite-Hite* or equal.

UTILITIES

- **HVAC:** Energy-efficient, roof-mounted *Cambridge* direct-fire units.
- **Electrical Service:** 800 amp, 480/277 volt, 3-phase service (expandable to 4000 amps).
- **Lighting:** Energy-efficient LED fixtures.
- **Fire Protection:** Early Suppression Fast Response (ESFR) sprinkler system.
- **Utilities:** All utilities shall be separately metered.
- Provisions for domestic water and natural gas shall be provided.

PARKING

- Asphalt paving, including heavy duty pave at truck areas and light duty pave in vehicle parking areas.
- On-site parking for approx. 84 vehicles.
- On-site trailer storage for approx. 17 trailers with 8' wide concrete dolly pad.

LOCATION

- Park is less than one mile from I-81 and I-476.
- Foreign Trade Zone status possible.
- Centrally located within Scranton/Wilkes-Barre labor market.
